MEDICAL KIDNAPPING, FORCED DRUGS, FALSIFICATION OF MEDICAL RECORDS, FAKE DOCTORS, MEDICAL MALPRACTICE, FAILURE TO TREAT INFECTION, FAILURE IN AFTERCARE, FAILURE TO PROTECT, ABUSE OF MEDICAL LISCENSES, DEPRIVATION OF SAFETY, DEPRIVATION OF ROOM WITH BATHROOM IN IT,

Demand for Jury Trial

Now comes the Plaintiff in the above entitled matter, who was recently medically kidnapped by the State of New Hampshire, and Cheshire Medical center and subsequent staff.

The Plaintiff sought help after losing 12 pounds, suffering from laryngitis for days on end, was sleep deprived, and her fiancé was killed on his way to fly to America, and she was shattered. Somewhere in her blur of tears, and falling in her own home on the way to the bathroom she felt she needed care to help her achieve solid sleep and called 911 to get her to the “hospital” i.e. Federal Government, trained murders who were waiting to give her another (3<sup>rd</sup> round of a drug cocktail, 2 prior such medical kidnappings had occurred in Massachusetts.)

The staff shoved drugs that were unrelated to a single condition, and meant to erase her memory, keep her unable to have coherency and function. Once put inside the hospital, it was only to medicate her that she was attended to, and her record was falsified that “so man visits” were made.

Drug dealers like this medical staff of criminals assume you don’t have a working brain cell when you do, and the Plaintiff remembers being drugged and then

asked if she swallowed her drugs and having to show them. All drugs were just a dangerous and sick mixture of typical sociopathic meds for people to attempt to falsify the Plaintiff's condition, and her actual condition, mourning the loss of a loved one, and sleep deprivation. No hospital gave the Plaintiff a single medication to allow for sleep.

The Plaintiff was put on IV, as she was only drinking water for hours on end, and only able to swallow small amounts of food. The Plaintiff had to go to the bathroom constantly to release the liquids, they NEVER gave her a catheter or bed pan, to keep her protected.

In their false medical record, they never once mention her mourning a death, being sick from not eating, or needing simply rest and recovery.

At one point from being weak and weary, the Plaintiff fell inside her room, and was further medically abused. They did not clean her wound or put antibiotics on it, they drugged her with a dangerous drug that has a side effect of "months of diarrhea" afterwards. They lied to the Plaintiff and told her if she did not take this medicine her arm would fall off. Doctors lied straight to her face.

She ultimately had to have a walker, when she still needed a bed pan, and some more food and IV to give her liquids and strength. She was in a blur and all of her timing and events were messed up. The Plaintiff has lost her memory for most of the events in June due to this massive dose of illicit drugs for her condition. Each person played a role in these crimes and doctors looked her right in the eyes.

While she was using a walker, they "booked her" for all kinds of appointments, and were trying to give her aftercare "dug cocktails" and expected the disabled Plaintiff to be pressured into these appointments, the hospital and doctors started calling her at home and trying to make sure she was "drugging herself" The Plaintiff was not, she took nothing of the prescriptions. The Plaintiff was not even clear days later where she had gone to fill the prescriptions, imagine that.

The hospital has only a 2.5 rating on the internet, as many had been medically kidnapped, drugged, mistreated, malpractice, you name it, and they do not care. Medical staff are SES, trained to abuse patients, and don't even blink, they have 0 remorse or guilt, they are addicted to their own power to abuse those in need.

## 1<sup>st</sup> Cause of Action – Medical Kidnapping

Abusing their power as “trained medical staff” they seized upon a 911 victim as their “prey” and immediately started medical torture and drugs, ignoring actual reason for being there = lack of sleep, need for food, and incredible suffering after a tragic death. All the Plaintiff's needs were cast aside, medical staff kidnapped the Plaintiff and started to drug her, making her incapable of even knowing she was in danger.

2<sup>nd</sup> cause of action – failure to note actual symptoms and condition and to replace that with a false narrative

3<sup>rd</sup> Cause of Action – forcing medicine down the throat of a victim, and lying about the medicine and its effects

4<sup>th</sup> Cause of Action – failure to ever treat actual symptoms and to protect victim while inside Cheshire Medical Center.

5<sup>th</sup> Cause of Action – Failure to administer bed pan, or catheter and keep patient safe.

6<sup>th</sup> Cause of Action – failure to treat injury, caused by negligent staff that knew Plaintiff was far too drugged and sleep deprived to safely reach bathroom while surviving on liquids. Medical malpractice to not even put antibiotic on injury so that they enabled infection. Plaintiff suffered this needed round of additional drugs, these people are sick.

7<sup>th</sup> Cause of Action – Lies from medical staff and doctors, including that the Plaintiff's arm would fall off if she did not ingest dangerous drugs.

8<sup>th</sup> Cause of Action – staff “booking” an incapacitated woman on a walker due to their negligence and mentally threatening her, trying to force her to irrelevant, unrelated, and unnecessary appointments, all for “notches on their SES belts”. These people are trained killers, not an ounce of protection for anyone.

9<sup>th</sup> Incompetence led to all of the above, and the assurance that the Plaintiff would have memory erased of the abuses, neglect, and harm they were doing to her. All staff lied to her face, a job requirement.

WHEREFORE, Damages need to be paid to the Plaintiff under the laws that prohibit kidnapping, drugging a person, falsification of a medical record, and insane negligence leading to injury and infection.

The Plaintiff demands \$5 Million dollars for the sick criminal abuse, and harm they did to the Plaintiff.
